1. After the end of the Second World War (1945), a number of Japanese soldiers and civilians for various reasons did not return to their homeland but continued to stay in Vietnam. The number of these Japanese was not accurate because of the turbulent context at that time. The majority of Japanese married Vietnamese women and become "new Vietnam citizens". These Japanese migrants participated in supporting the new Vietnamese government. For their wishes, during the period from 1954 to 1960, there were a total of five repatriations for Japanese returning hometowns. The Vietnamese government had policies to support the return to Japan. By the end of 1960, the last Japanese soldiers and civilians in North Vietnam were repatriated with their families to Japan.

During the time of doing this research, I found that the Vietnam National Archives Center III is preserving many important documents on the Japanese people, records of background, as well as quite detailed statistics on names, ages, and hometowns of the Japanese staying in Vietnam. The extraction of valuable information from these archival materials enabled me to draft a research paper on the repatriation of Japanese in Vietnam from 1954 to 1960.

3. Through the surveys, I obtained a great deal of information about the life of these Japanese soldiers as well as their spouses. These days, most of the wives of the Japanese soldiers are too old and died. However, their grandchildren started to reconnect with their relatives in Japan and Vietnam.
